## **DISCUSSION -** To adopt the 2021 Final Budget

Mr. McDonald stated the board received an email from Greg Mills, Chairman of Youth Commission and Mr. John Flynn Youth Director at approximately 5 PM, November 16, 2020 stating Mr. Flynn was declining the 2.5% raise and additional \$ 100.00 for 2021. Mr. McDonald confirmed the \$100.00 was part of the PS line with Ms. Barber. Therefore the additional \$ 100.00 could be declined. The board voted unanimously to accept Mr. Flynn's request.

Ms. Barber questioned why Mr. Flynn was declining as he had called a Councilman to question why he was only getting a 2.5% increase. Mr. Barber replied because it was not enough.

Mr. McDonald stated he would reject his raise and 2.5% for 2021. No raise for a supervisor had been taken in 2013, 2016, 2017, 2018, 2019 and 2020. He felt it was the right decision during the pandemic. Mr. Bruno stated he felt very strongly that Mr. McDonald should not reject his raise.

Mr. Douglass, Mr. Barber, Mr. Irwin and Mr. Bruno each declined their raises including the 2.5%. The Councilmen also felt due to the pandemic they would reject theirs.

Mr. Barber remarked the actions and involvement of the Board will speak for themselves in the upcoming projects.

The board voted unanimously not to accept 2.5% increase or additional raise for 2021.
