Mr. Randall stated a community member questioned the progress of the Telegraph Road culvert and that the permits had not been completed. Ms. Barber spoke with the engineers and asked to clarify the permitting procedures, if the timeline of the project is on schedule, and requested to have monthly updates for future town meetings. C & S Engineers' Comments on "Incomplete Permit":

- As this is an NYSDEC classified S1/S2 mussel stream, a Mussel Survey was required to be completed within the summer months.
- The permit they found was required by NYSDEC for the Mussel Survey for the sole purpose of establishing a NYSDEC permit number for the project. A mussel survey cannot be completed without this permit number and an incomplete permit is always shown at this phase of preliminary design because of the required mussel survey. This is why an "incomplete permit" status is currently shown, as this is part of the NYSDEC system.
- A separate Joint Permit Application (NYSDEC and USACE) is required for the replacement structure and will be completed during the final design phase and sent to both NYSDEC and USACE.
